2014 AMERICAN LECTURE IN THE HISTORY OF RELIGION SERIES: **CATHERINE ALBANESE**



In an American Kaleidoscope: Revisiting Two **Centuries of American Religious History**

Kaleidoscopes mean connections and surprising collisions, instances of one thing bouncing off another in unexpected ways. This lecture series will explore two centuries of American religious history with an eye for the kaleidoscopic. The

lectures will uncover connections hidden in plain view as well as ironic collisions and reconfigurations—this mostly for the Anglo-Protestant "mainstream," and the spin-offs it never anticipated or thought it wanted. Lectures will focus on the long season of eighteenth-century revivals often called the Great Awakening, the religions of the American Revolution, God's time in American evangelicalism, new nineteenth-century religious women, and the high road from evangelicalism to mind cure. The lecture course covers the following themes:

When Is God's Time? Watching the Religious Clock in Antebellum America

NEED A PROFESSIONAL MENTOR? CALL FOR MENTORING APPLICANTS

The American Academy of Religion (AAR) announces the continuation of the mentoring program piloted in 2013/2014. This program is an initiative of the four standing committees of the AAR: Status of Lesbian, Gay, Bisexual, Transgender, Intersex, & Queer Persons in the Profession (LGBTIQ); Status of Women in the Profession (SWP); Status of Racial and Ethnic Minorities in the Profession (CREM); and Status of People with Disabilities in the Profession (PWD). It grew out of successful mentoring lunches during the annual meetings, informal mentoring opportunities, and an expressed need by the members of these underrepresented groups. Thirty-five (35) post-comprehensive exam doctoral students, nontenured (i.e., pre-tenure, adjunct, contract) faculty, and/or post-doctoral fellows will be matched with participating senior scholars who will serve as mentors for a period of one year beginning in November 2014 at the annual meeting in San Diego. The mentor will offer guidance with some of the following where possible: professional development/discernment, access to networks, strategizing about publication(s), job-seeking (including jobs outside the academy or outside the tenure track), the tenure and promotion process, and work/life balance.

We are especially soliciting stories and/or strategies that draw others deeper into the complex challenges of and diverse visions for work/life balance. Stories may reflect upon both successful and unsuccessful

navigations of career, family, community, and personal lives, and strategies can be in a plurality of institutional and career contexts as long as they speak to practices for self-care and wellness. With this invitation, we are specifically seeking stories and strategies that should address AAR members, but they need not be academic in tone. CALL FOR RELIGION IN TRANSLATION BOOK SERIES EDITOR

The AAR Publications Committee seeks a book editor for the Religion in Translation Series, which is sponsored by the American Academy of Religion and published in cooperation with Oxford University Press. The Religion in Translation series seeks to make available to research scholars and classroom teachers alike significant primary texts in English translation, important secondary scholarship on religious texts, and reprints of major theoretical works in the field of religious studies. Given this broad mandate, proposals are sought from all areas of the discipline that will bring to an English-speaking audience texts of major importance to the world's religious traditions, monographs that open up specific texts to wider audiences, and new translations of classic works of secondary scholarship that are perennially relevant to the understanding of religious phenomena, values, ideas, and practices. Books published in the series may be found here.

AAR Series Editors help set editorial policy, acquire manuscripts, and work with Oxford University Press in seeing manuscripts through to publication. Editors sit on the AAR Publications Committee for the duration of their five-year (renewable once) term. This is a volunteer position. All applicants must be members of the American Academy of Religion.
